### **Description of Qualified Investment**

OCI Hillsboro Solar LLC proposes to construct a 200 MW (AC) Photovoltaic solar facility and optional 200 MW battery energy storage system that would be sited on approximately 1300 acres of land approximately 1 mile south of the city of Bynum in Hill County. This application covers all qualified property in the reinvestment zone and project boundary within Hill County necessary for the commercial operations of the proposed solar project.
