**WAIVER OF TRIAL BY JURY**

**A. Waiver of Trial by Jury.** Defendant will plead guilty or no contest to said charge and hereby requests the consent and approval of the Court and the Attorney for the State that Defendant may waive the right to trial by jury herein, and does upon the consent of the Court and State’s Attorney waive trial by jury and enter his/her plea of guilty or no contest; and Defendant may waive the ten (10) day waiting period for trial.

**B. Waiver of Record.** Defendant hereby requests the consent and approval of the Court and of the Attorney for the State that Defendant may waive the right to making of a record of these proceedings, and does upon the consent of the Court and State’s Attorney waive the making of a record at these proceedings.

**C. Waiver of Presentence Investigation Report.** Defendant hereby requests the consent and approval of the Court and of the Attorney for the State that Defendant may waive the right to have a PSI report prepared by a supervision officer, and does upon the consent of the Court and State’s Attorney waive the preparation of the PSI report.

**D. Waiver of Risk and Needs Assessment.** In accordance with Article 42A.301 of the Code of Criminal Procedure and joined by my attorney (if any), and consent and approval of the Court, I knowingly and voluntarily waive my right to the requirement of a risk and needs assessment be conducted and expressly request that such assessment not be required prior to the court determining the conditions of community supervision.
